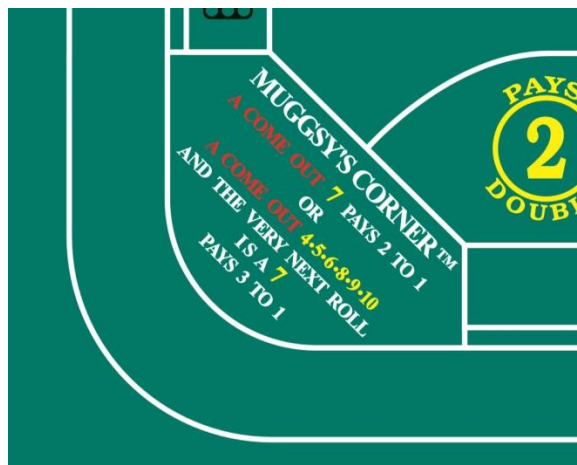
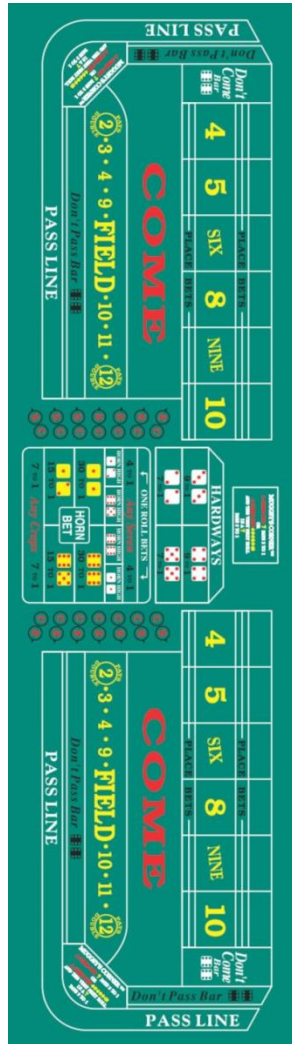

This brand new bet adds another flavor of excitement to this classic game of craps where players have two chances to win. If a 7 is hit on the come-out roll then the Muggsy's Corner™ bet wins and the players are paid 2 to 1. If a 4-5-6-8-9-10 is hit and the very next roll is a 7, the Muggsy's Corner™ bet wins and the players are paid 3 to 1. This straightforward bet is effortless for new players to learn and has a house edge of 5.5% which is the same as the field bet. Join the fun at the corner. What corner? Muggsy's Corner™!

## Muggsy's Corner™ Dealing Procedure

---

Welcome to Muggsy's Corner™ training ground! To start, players will place their wager during the come-out roll only. If a 7 is hit on the come-out roll, Muggsy's Corner™ wins and players are paid 2 to 1. If a 2, 3, 11 or 12 are rolled, players lose and their chips will be taken. If a 4, 5, 6, 8, 9 or 10 are hit, then the puck will be marked as *WORKING* locking all Muggsy's bets in place, NO additional bets will be placed or taken at this time. If the very next roll is a 7, players are paid 3 to 1. If anything other than a 7 is rolled, players lose, their bets will be taken and the puck will be marked as *OFF*. This straightforward new bet is effortless for players to learn and has a house edge of 5.5% which is the same as the field bet. Players are required to wait for the next come out roll before they can place a bet on Muggsy's Corner™ again. ## BMM EVALUATION TEST REPORT

### 1. PURPOSE

FM Gaming, L.L.C has requested BMM Testlabs to perform a mathematical evaluation on the game Muggsy's Corner. This evaluation tested the math for correct Return to Player (RTP) and compliance of the Top Award odds.



### 2. MUGGSY'S CORNER RULES AND PAYTABLE

Muggsy's Corner is an optional side bet for the game of craps. It is played over the next one (1) or two (2) rolls of the two (2) dice. The rules and payable are given below:

- Before the come-out roll, a player may place the optional Muggsy's Corner wager.
- If the shooter's come-out roll is a 7, the player is paid 2:1 on their Muggsy's Corner wager.
- If the shooter come-out roll is a 4, 5, 6, 8, 9 or a 10:
  - If the shooter's very next roll is a 7, the player is paid 3:1 on their Muggsy's Corner wager.
  - Otherwise, the player loses their Muggsy's Corner wager.
- If the shooter come-out roll is a 2, 3, 11 or 12, the player loses their Muggsy's Corner wager.
- New Muggsy's Corner wagers can be placed prior to the next come-out roll.
- The pays for Muggsy's Corner are summarized in the following table:

| Outcome       | Paytable 1(to 1) |
|---------------|------------------|
| 7 on 1st roll | 2                |
| 7 on 2nd roll | 3                |
| Others        | -1               |

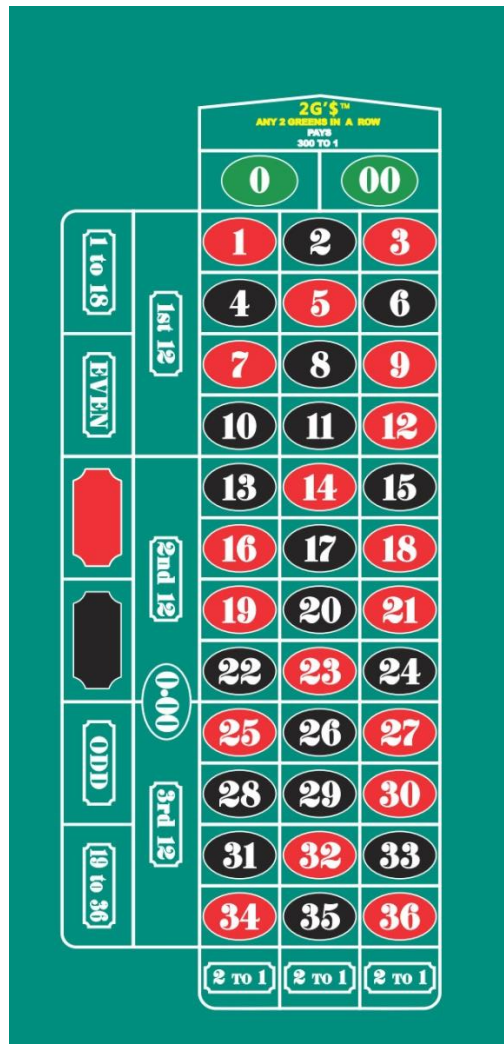

### 1. PURPOSE

FM Gaming, L.L.C has requested BMM Testlabs to perform a mathematical evaluation on the game: 2G'\$. This evaluation tested the math for correct Return to Player (RTP) and compliance of the Top Award odds.



### 2. 2G'\$ RULES AND PAYTABLE

2G'\$ is an optional side bet for the game of roulette. It is played over the next one (1) or two (2) spins of the wheel. The 2G'\$ wager wins if the next two (2) spins are green numbers (0 or 00). The rules and paytables are given below:

- Before any spin, a player may place the optional 2G'\$ wager.
- If the first spin is not a green number, all 2G'\$ wagers are collected and the wager may be made again on the next spin.
- If the first spin is a green number:
  - The dealer freezes the bets on that next spin, no new 2G'\$ wagers may be made.
  - If the next spin results in a green number, all 2G'\$ wagers are paid according to a paytable.
  - If the next spin is not a green number, all 2G'\$ wagers are lost and collected by the House.
- The payable choices for 2G'\$ on American style roulette wheels (having 0 and 00) are as follows:


