BIG SIX PROCEDURES

- ☀ It is your responsibility to know the minimum and maximum bets when coming on your game.
- ☀ The minimum bet must be attained on each betting spot, i.e. bets on separate 1's cannot be added together to meet the minimum.
- ☀ If a bet appears to be over the table maximum and the wheel is spinning, call out "Checks/ Money Plays to the Limit".
- ☀ Wait until all bets are placed and announce "No More Bets" before spinning the wheel. Do not accept any bets while the wheel is in motion.
- ☀ Turn the wheel by grasping the outer edge. Never spin the wheel by the pegs.
- ☀ Walk the wheel at least twice before giving it the final spin.
- ☀ Once the wheel has been spun, do not allow Players to make additional bets or alter any existing wagers.
- ☀ The wheel must make at least three revolutions after you release it from your hand.

Alternate the direction of the wheel each spin.

- ☀ **Use the mirror to determine the winning number.** Position the mirror and stand in a place where you can see both the number and your entire layout. **Do not block your view of any betting spot with the mirror.**
- ☀ **Never turn your back to your game to see the winning number.**
- ☀ Verbalize the winning number and the number of winning bets as soon as the wheel stops spinning. Point to the winning number on your layout before collecting the losing bets.
- ☀ Clear losing bets from the layout working from the outside to the inside. Politely ask your Players to hold their betting until all winners have been paid. If Customers do attempt to wager before you are finished paying off, courteously remind them to wait.
- ☀ **When the indicator stops between two numbers, the winning number is unable to be determined and must be declared "No Spin".** This rule is represented on your table limit sign.
- ☀ Any mechanical malfunction will result in a "No Spin". Call your Floor Supervisor.
- ☀ Payoffs will be made from the outside of the layout to the inside. Do not allow your Players to pick up their winnings or place new bets until you have paid all the winners.
- ☀ Determine the amounts of all winning bets and cut out the payoffs in your work area. Winners on the 1 and the 2 may be sized into directly on the layout.
- ☀ Notify your Floor Supervisor before making any payoff over \$200.
- ☀ Use fresh checks from your rack for all payoffs. Never use dirty money, no matter how convenient it might seem.
