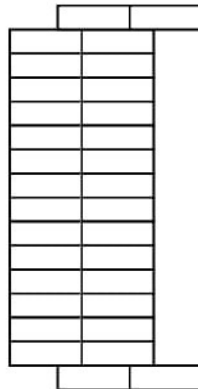




2. Most deliveries will be accepted as long as they are indicated clearly and are approved by both the Floor Supervisor and Dealer.

NOTE: The delivery Teen Lar Day Mong is not allowed.

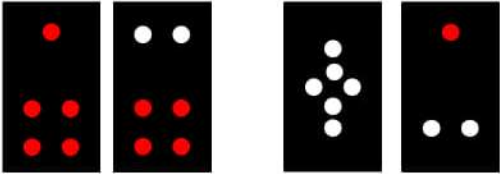
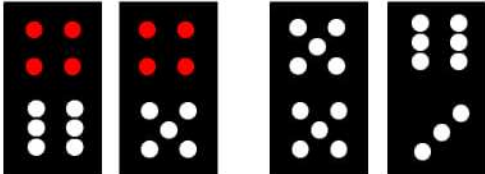
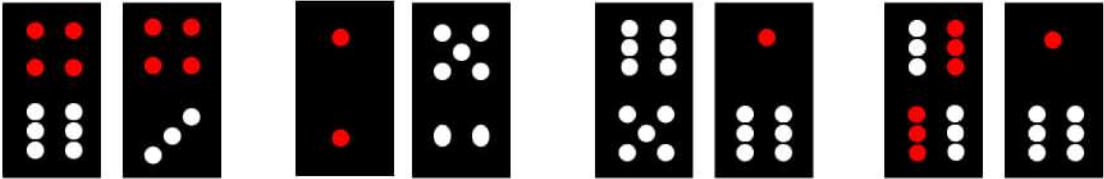


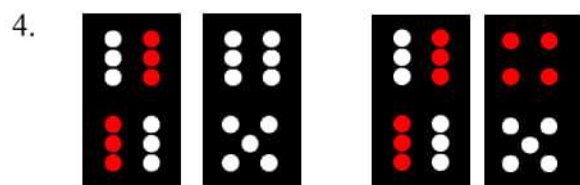
PAI-GOW TILES HOUSEWAY

1. PAIRS – ALWAYS PLAY PAIRS TOGETHER.
EXCEPTIONS: (refer to the illustration 1-5)
 - a. Split Gee Joon with any 6-4, 6-5 or 6-6.
 - b. Split 2's and 12's making 6-8 or better. Also split with 9-11.
 - c. Split 9's with 10's, 2's, 12's.
 - d. Split 8's to make 7-9, 8-8 or better.
 - e. Split 7's with 2 (12) and 10 or 2 (12) and 11..
2. PLAY HIGH 9, GONG, WONG.
 - a. PLAY A 12 OR 2 WITH A 7, 8 OR 9.
 - b. WHEN HAVING BOTH 12 AND 2, ALWAYS PLAY 12 IN HIGH HAND AND 2 IN LOW HAND. EXCEPTIONS: (refer to illustrations 9 & 10)
 - Play Gong over high nine when fourth tile is any 4 or third and fourth tiles are low 8 and 5.

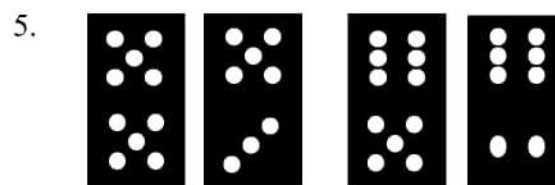
- With the low 4, play Wong over high 9.
 - Always play Gong over Wong unless fourth tile is an 11.
 - With both 12 and 2, any 10 and 11, play high 2 and low 3.
3. PLAY HANDS AS CLOSE TOGETHER (IN VALUE) AS POSSIBLE.
EXCEPTIONS: (refer to illustrations 11 – 14)
 4. WHEN THE LOW HAND IS NOT A CHONG THREE OR BETTER, MAKE THE HIGH HAND THE HIGHEST RANKING 9.
** (ONLY IF YOU CAN MAKE 9 IN THE HIGH HAND.) (refer to illustration 25)
 5. WHEN THE LOW HAND IS TWO OR LESS, MAKE THE HIGH HAND 7 OR BETTER.
(refer to the illustrations 16-20 & 26)
 6. WHEN THE HAND IS 7-9 OR LOWER, ALWAYS PLAY THE HIGH TILE ON THE LOW HAND.
EXCEPTIONS: (refer to the illustration 15 & 21-24)

***Please note the changes in rule #4 and illustration 14, 15 & 27.

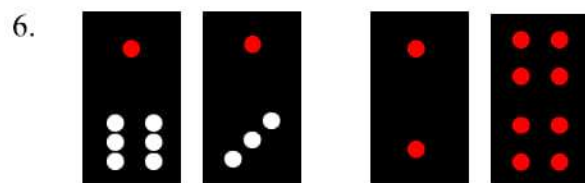
1.  Split Gee Joon with a 6-4, 6-5 or 6-6.
2.  Split 9s with any combination of 10s, 2 and 12.
3.  Split 7s with a 2 and 10, 11 or 12; or a 12 and 10, 11 or 2. Must have either 2 or 12.



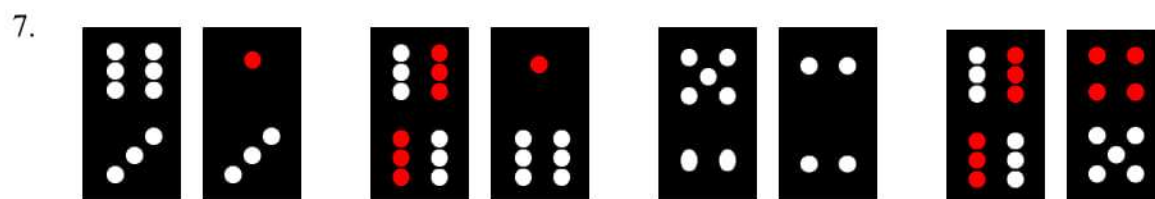
Split 2s and 12s to make 6 and 8 or better.
Also split with 9-11.



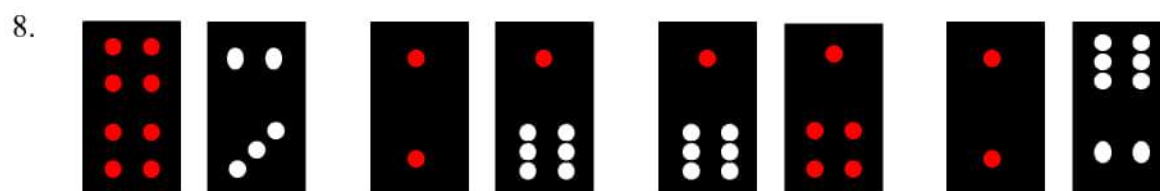
Split 8s with any combination of 10s, 11, 2 or 12.
Also with 9-11.



With a 2 or 12, and an 8 and a 7, play the Gong over the 9 when the fourth tile is a 4.



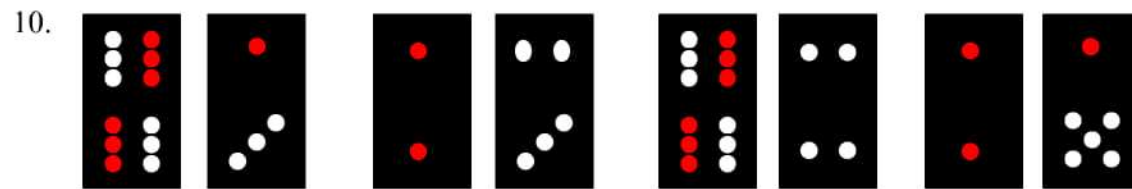
With a 2 or 12, and a 7, a 9 play 3-9 with high 4; play 1-Wong with low 4.



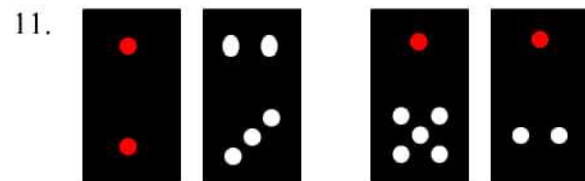
With a 2 or 12, and a 5, a 7, an 8 play 3-9 with high 8 play 2-Gong with low 8.



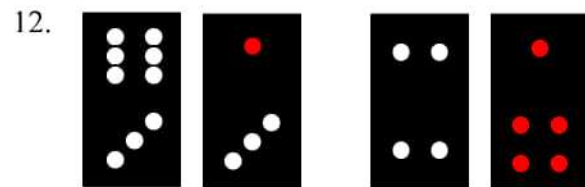
With a 2 and a 12, if the low hand is 7 and the high hand is 8, play the 12 on the high hand.



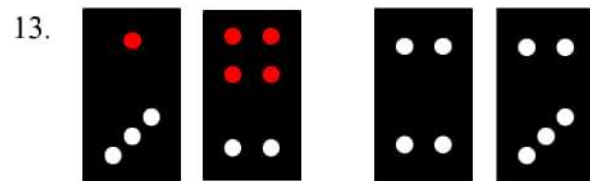
With a 2 and a 12, a 4, and a 5 or 6, play the high 6.



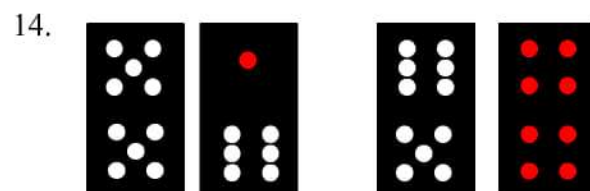
With a 3, a 5, a 6, and a 2 or 12, play 7-9 instead of 8-8.



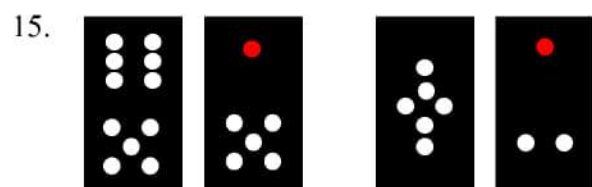
With both 4s, a 5 and a 9, play high 3 – low 9.



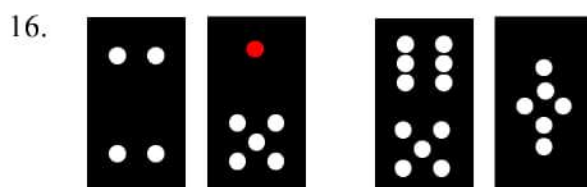
With a 3, both 4s and a 5, play high 7 – low 9.



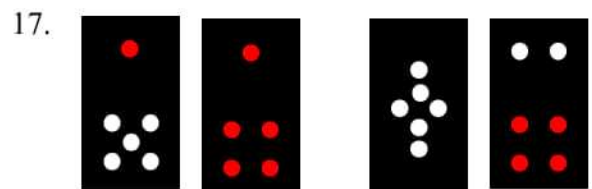
With a 7, a high 8, a **high** 10 and an 11, play 7-9.
(otherwise play 8-8)



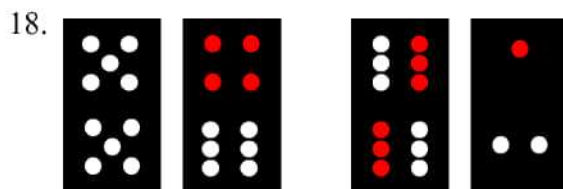
With a 3, both 6s and an 11, play the high 9.



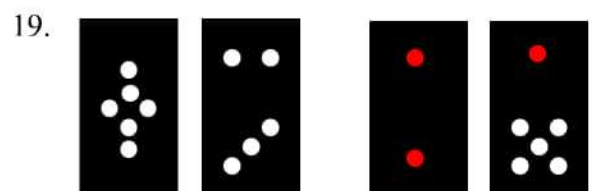
With an 11, both 6s, and a 4 or 5, play 0-high 7 or 1-high 7.



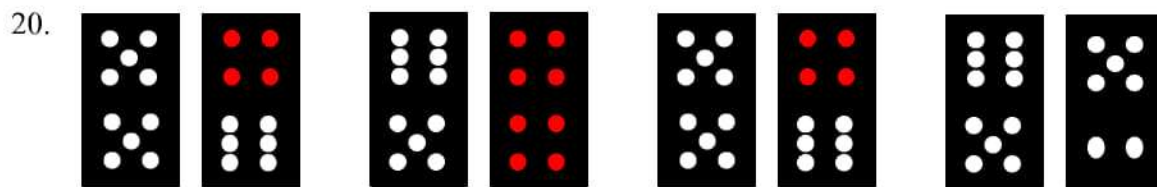
With a 3, both 6s, and a 4 or 5, play the high 9.



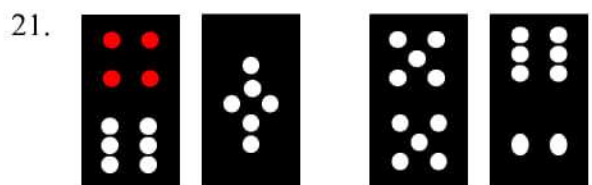
With a 2 or 12, both 10s, and a 6 or 5, play 0-8 or 0-7.



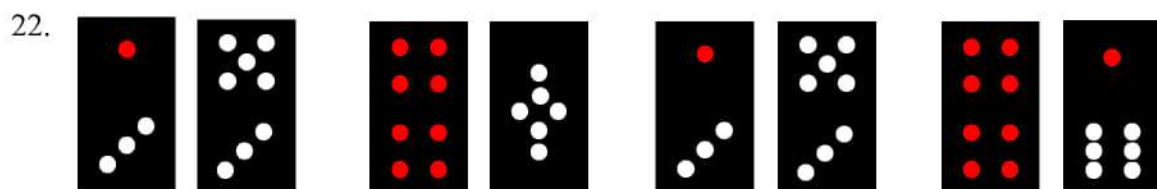
With a 2 or 12, both 6s, and a 5 or 4, play high 1-8 or 0-8.



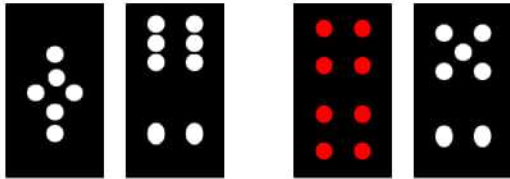
With an 11, both 10s and either 8 or 7, play 0-9, or 0-8.



With a high 6, both 10s, and a 7, low 8 or 9, play the high 10 on the high hand.

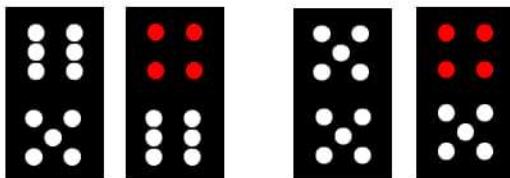


With a high 4, both 8s, and a 6 or 7, play the high 8 on the high hand.



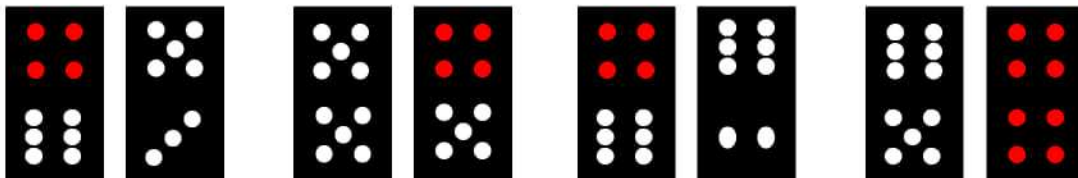
With a high six, both 8s, and a 7, play the high 8 on the high hand.

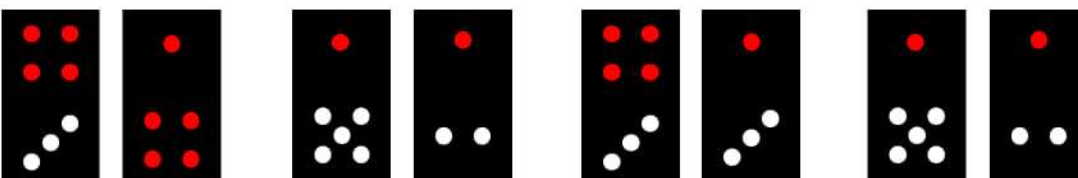
With both 10s, a 9 and an 11, play 1 high 9.

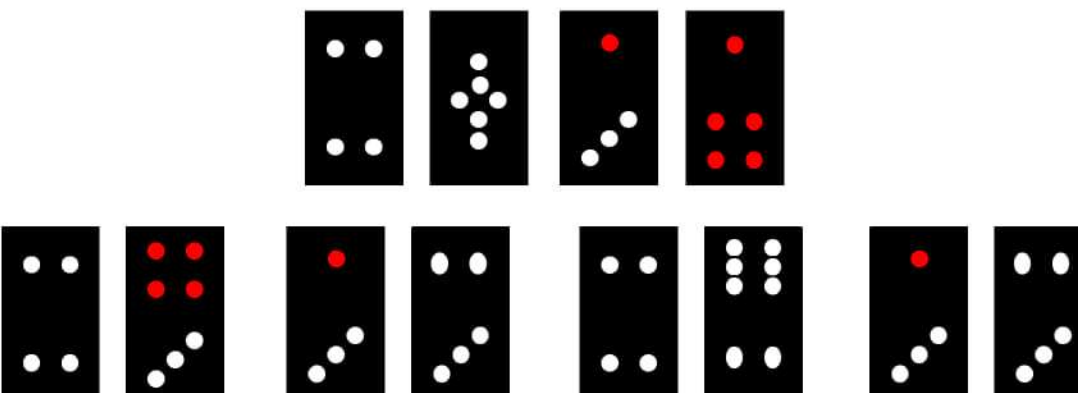
With both 10s, an 8 and a 9; or a 10, an 11 and both 8s, play the high 9.

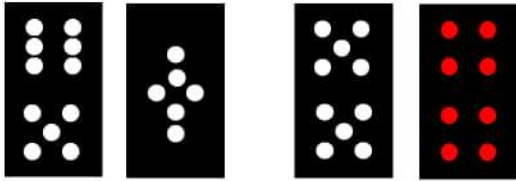
With a 3, a low 6, a 7, and a 5 or a 4, play 2-9 or 1-9.

With both 4s, a 5, and a 6, 7 or low 8, play the high 9.

With an 11, a high 10, a high 8 and either 6, play 7-8.
